

Competition rules
Film Bootcamp
Transylvanian Moviepreneurs

1. General provisions

Art. 1. These regulations specify the terms and conditions of the event.

1.1. The organisers of the Transylvanian Moviepreneurs Film Bootcamp are **23 FILM, Civitas Foundation** and **Projects Iceland**.

1.2. The programme takes place in Cluj-Napoca, Romania.

1.3. Participants can take part in the programme in September 2021.

1.4. The duration of the programme is **12 days**, with daily schedule 10:00-20:00, including breaks.

1.5. There is no participation fee for this programme.

1.6. Meals are provided.

2. Programme application and eligibility conditions for participants

Art. 2. To participate in this programme, the terms and conditions of eligibility must be met.

2.1. The programme is open to young professionals aged **22-35**, students or graduates in the **audiovisual** field (Film, Theatre, Television, Journalism, Digital Media, etc.).

Future participants will be selected as follows:

- future participants in the **directing-scenario** groups will have to send a **showreel** of productions in which they have worked as **directors** or a **treatment**;

- future participants in the **picture, editing, production** groups will have to submit a **showreel** of productions in which they have worked as **picture directors, editors** and **production assistants**;

- future participants in the acting group will have to send a **monologue recorded** with their phone and a **head-shot** photo.

2.3. Participants will be given a **single filming location** and a **predetermined theme** to work on;

2.4. The application form will be available on the Transylvanian Moviepreneurs website - **transylvanian-moviepreneurs.ro**;

2.5. The shortlisting and final selection for the **18 positions** (3 directors, 3 DPs, 3 editors, 3 producers, 6 actors - divided into groups) will be carried out by a specialised jury.

2.6. The deadline for applications is the end of 30 July 2021.

3. Copyright

Art. 3. In order to participate in this programme, the terms and conditions in accordance with the assignment of copyright must be met.

3.1. 23 FILM, being the sole producer of the programme, reserves the copyright on the productions and photo-video promotional materials produced during the activities.

3.2. 23 FILM will be solely responsible for the dissemination of the video materials produced by the participants and for the promotion of the photo-video materials produced by the implementing team.

4. Privacy Policy regarding the processing of personal data

4.1. Participation in this training programme implies the participants' agreement that personal data will be collected and stored by the organiser in the event of potential information.

4.2. The organiser will not pass on personal data except to companies involved in the organisation of the programme. Participants are guaranteed the rights provided for by Law No 677/2001 on the protection of individuals with regard to the processing of personal data, with regard to the processing of personal data and the free movement of such data.

5. Final regulations

5.1. The organisers are obliged to comply with the provisions of these regulations for the registration, admission and running of the bootcamp.

5.2. The organiser reserves the right to suspend the activity of any participant in case of non-compliance with the conditions imposed by these rules.

5.3. The organiser reserves the rights to the entire training programme and implicitly the copyright to the short film produced as a result of the mentoring programme.

Annex 1

Agreement for the use of personal data

As of 25.05.2018, Regulation (EU) No 2016/679 of 27.04.2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data (abbreviated GDPR) entered into force, which regulates the use of personal data for natural persons.
